PROGRAM: PDG Bill Gormont presented an overview of the Strategic Planning process for Rotary clubs. He outlined the six steps in the process as well as the key components which include; 1. Proposed changes to Bylaws are in **RED** below:

Article 13 Members/Method of Electing Members

Section 1 - The club offers the following membership types:

- a. Individual Member: These members enjoy all the benefits, opportunities, and responsibilities of Rotary.
- b. Corporate Member: This type of membership is available to a business, organization, government entity, professional practice, educational institution, and other entity located in, doing business in or otherwise having some presence in the Phelps – Clifton Springs Central School District. A corporate member may designate one primary designee and up to three additional designees. The primary designee only shall enjoy all the benefits, opportunities, and responsibilities of Rotary. Corporate Membership requirements shall be established by the board.
- c. Family Member: This type of membership is available to family members. A family may designate one primary member and up to three associate members. The primary member only shall enjoy all the benefits, opportunities, and responsibilities of Rotary. Family Membership requirements shall be established by the board.
- d. Honorary Member: As listed in Section 8 of the Bylaws
