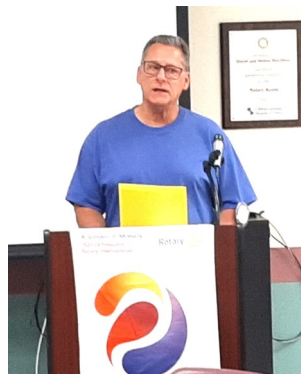
## ANNOUNCEMENTS:

**Clifton Springs Rotary Club Family Membership Eligibilities and Guidelines**

**Membership eligibilities:**

Any immediate family member (spouse/partner, **adult** children *18 years or older* and, if appropriate, parents or grandparents) is eligible  
These family members must reside at the same residence address.

**Family Membership guidelines:**

**Application and approval.** A household may apply for Family Membership. Approval of application must follow the standard club membership application process.

**Designees.** There will be a Primary member and secondary designee(s). The primary and secondary members must be approved through the standard Club Membership application process. With a full-dues paying member of the family, the club may allow a set number of secondary designees.

**Financial obligations.** Primary member is expected to pay **the full annual membership dues (RI, District & Club)**. Both the primary and secondary members are encouraged to make annual donation to the Rotary Foundation and support any or all fund-raising projects, etc.

**Member Registration.** Upon approval, the Primary member is registered with the club as an Active member and will be included in the Club Membership roster that is submitted to Rotary International.

**Attendance/engagement.** The Primary is expected to adhere to the club's attendance/engagement requirements; however, the attendance and engagement participation of the secondary designee(s) will count toward the primary member's record. There are no attendance requirement for secondary designees.

**Classification.** Classification of the Primary person will be considered for the club's classification limitations and based on the person's current or former business, profession, or type of community service.

**Badges.** The Primary member will receive a regular Member badge that is given to all Club members. Secondary may receive the same or other type identification card/badge, set by the club.

**Votes and Quorum.** For the purpose of general meetings and club matters, **only the primary member will have one vote and be counted for quorum purposes.**

**Holding Office.** The primary member may hold any Rotary Club office in which he/she is elected following the current Club policy and procedures. The secondary member(s) may not hold club office; however, could become a member of a Club committee.

**Changing secondary designee(s).** Should the Primary member decide to change the secondary designee, the Primary member must propose the replacement secondary member who will be selected and approved via current membership application process.

**Club bylaws-** the club must include in their bylaws any changes that they introduce in their membership classification.
